## Objective and Investment Policy

The objective of the Sub-Fund is to track the performance of the Bloomberg MSCI ESG Euro Corporate Select Index and to minimize the tracking error between the net asset value of the Sub-Fund and the performance of the Index. The Sub-Fund aims to achieve a level of tracking error of the Sub-Fund and its index which will not normally exceed 1%.

The Index is a coupons reinvested index: coupons paid by the debt securities comprising the index are included in the performance of the Index. Bloomberg MSCI ESG Euro Corporate Select Index is a bond index representative of investment grade fixed rate corporate bonds denominated in euro that follows the rules of the Bloomberg Barclays Euro Aggregate Corporate Index (the "Framework index ") and applies additional sector and ESG criteria for stock selection.

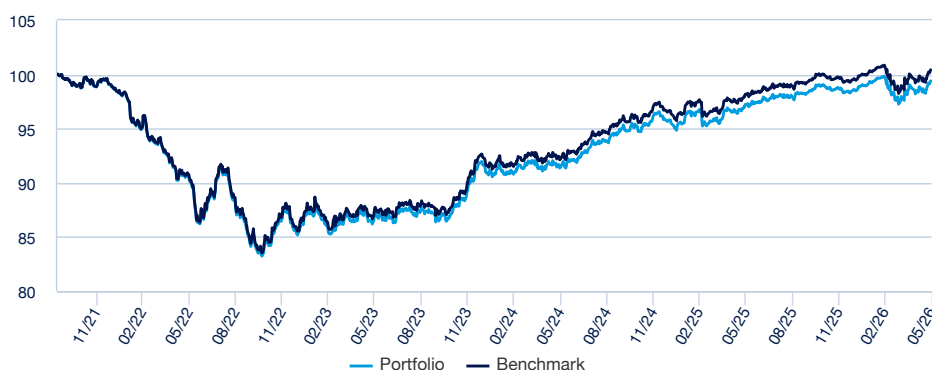

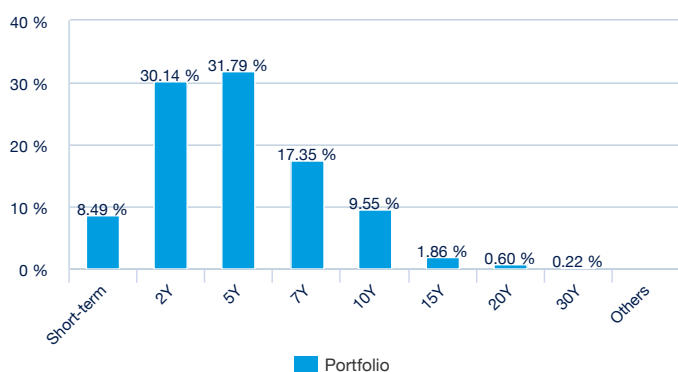

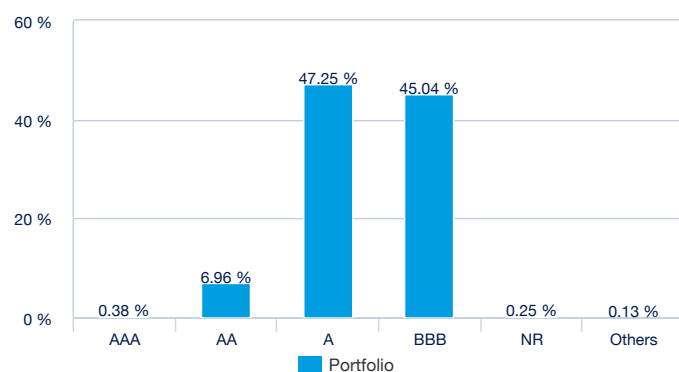

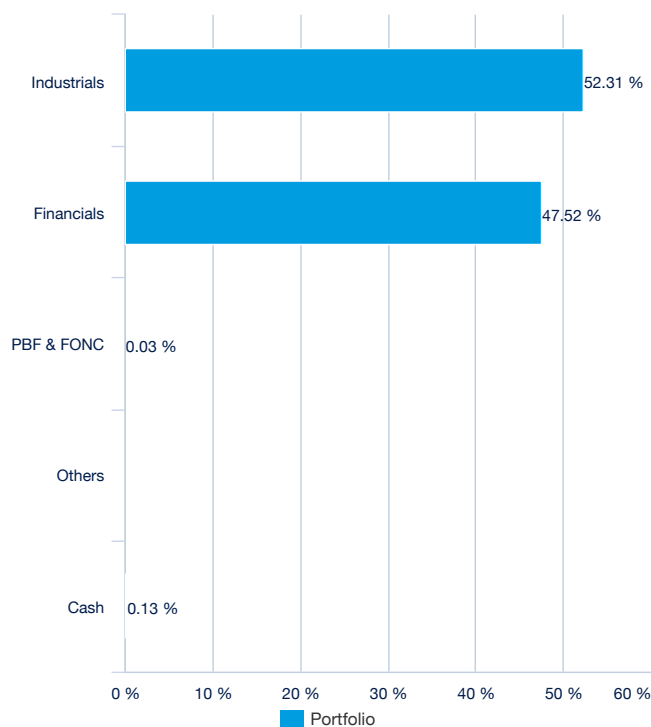
## By maturity (Source: Amundi)



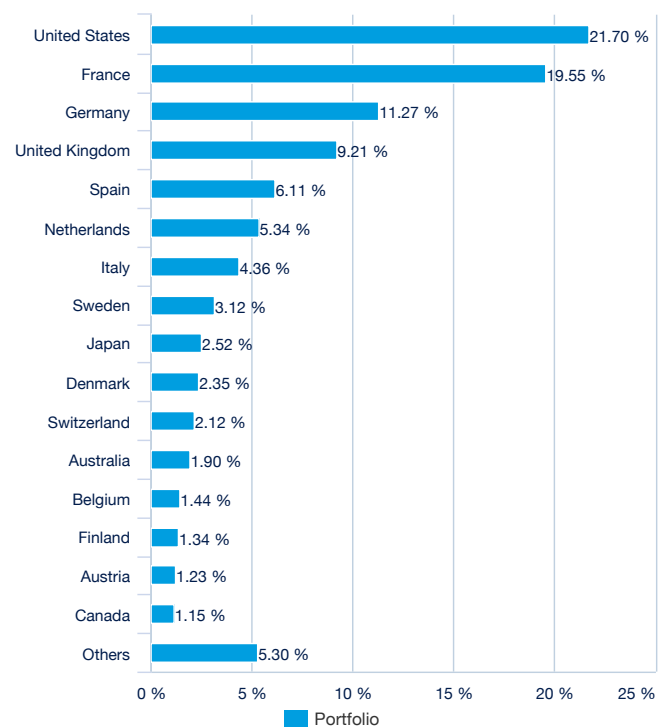
