The SubFund aims to achieve a level of tracking error of the Sub-Fund and its index that will not normally exceed 1%.

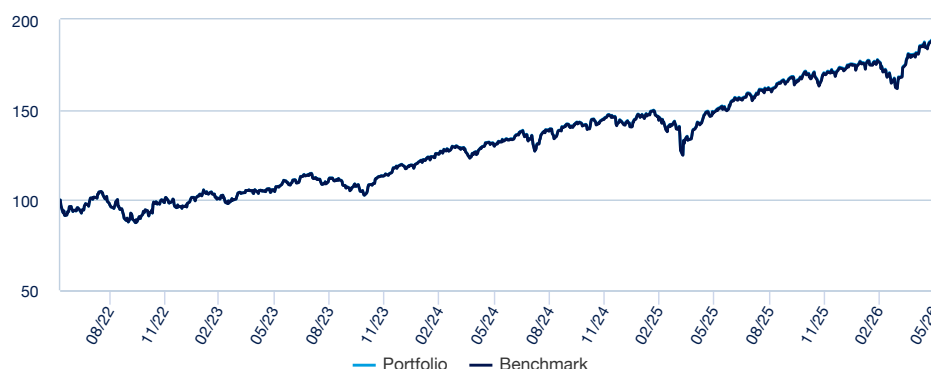

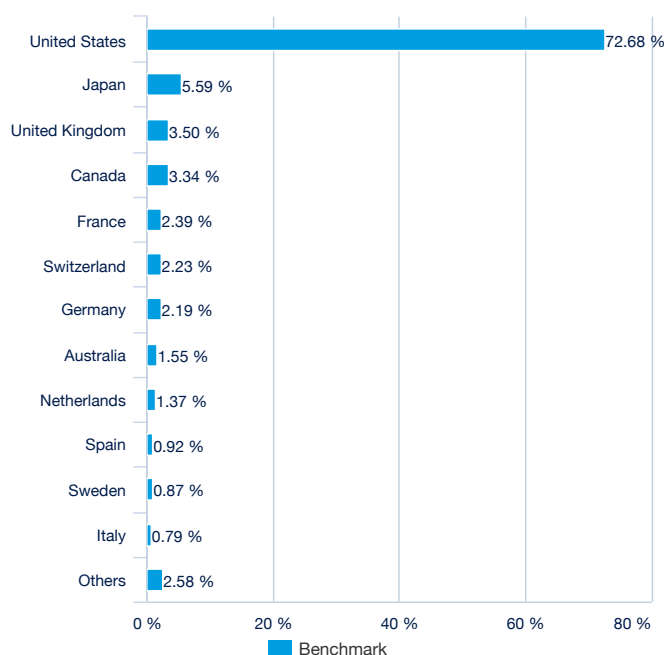

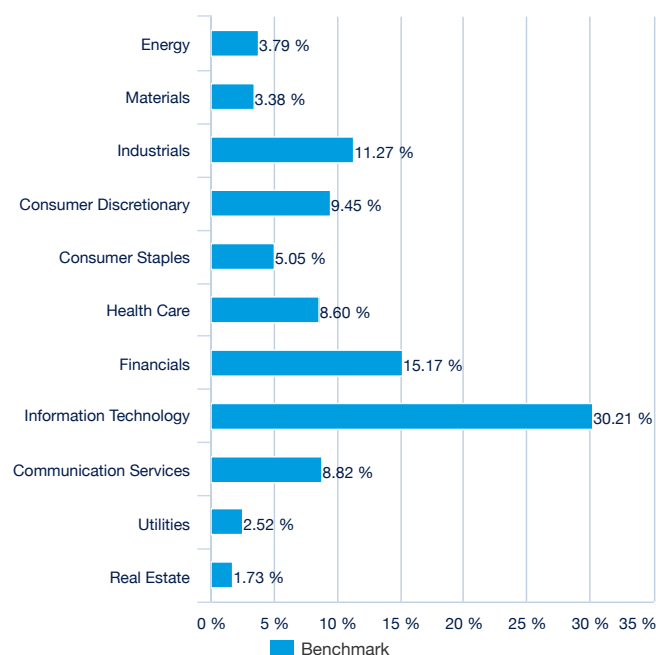
